Subject: Implementation of Revised Progression (ATKT) Rules as per University Circular for Undergraduate Programmes

All students are hereby informed that, in the interest of students and in alignment with the University of Mumbai Circular No. AAMS\UGS/ICC/2025-26/38 dated 28th May 2025, the progression rules (ATKT rules) for Undergraduate Programmes have been revised and adopted by the college.

The rules are as below:

R-1: Carry Forward of Marks in Case of Failure in Internal or Semester-End Exam

1. A learner who passes in the Internal Examination but fails in the Semester End Examination of the course shall reappear for the Semester End Examination of that course. However, his/her marks on the Internal Examination shall be carried over and he/she shall be entitled to the grade obtained by him/her on passing.
2. A learner who passes in the Semester End Examination but fails in the Internal Assessment of the course shall reappear for the Internal Examination of that course. However, his/her marks on the Semester End Examination shall be carried over and he/she shall be entitled for the grade obtained by him/her on passing.

R-2: Progression Rules for UG Programmes

1. A learner shall be allowed to keep term for Semester II irrespective of the number of courses of failure in Semester I.
2. A learner shall be allowed to keep term for Semester III if he/she earns 32 or more cumulative credits from Semester I & II.
3. A learner shall be allowed to keep term for Semester IV irrespective of the number of course of failure in Semester III.

4. A learner shall be allowed to keep term for Semester V if he/she earns 76 or more cumulative credits from Semester I, II, III & IV.
5. A learner shall be allowed to keep term for Semester VI irrespective of the number of courses of failure in Semester V.
6. The result of Semester VI shall be withheld until the learner passes all courses from Semesters I to V.
7. A learner may take admission in Semester VII (UG Honours / PG Part I) only if he/she has passed all courses from Semesters I to VI (i.e., obtained 132 credits).

Important Instructions:

These revised rules shall be applicable to students admitted from the academic year 2024-25 onwards.

Students who have already secured admission for the academic year 2025-26 shall not be affected by this change.

However, those students who do not fulfil the revised eligibility criteria shall be admitted based on the earlier eligibility norms, applicable prior to this change, for this academic year only.

Eligible students are required to contact the Admission Committee at the earliest to complete the admission process for the next semester as per the revised rules.
